## Explicit threats and the indiscriminate firing of mortars and small arms by BGF soldiers in Bu Tho Township, Hpapun District, June 2015

This News Bulletin describes events occurring in Bu Tho Township, Hpapun District in June 2015, including explicit threats and the indiscriminate firing of small arms and mortars by Border Guard Force (BGF) soldiers. The first incident took place on June 13<sup>th</sup> 2015, when the soldiers of Htoo Lwe Baw Company from BGF Battalion #1015 shelled mortars and fired small arms into P--- place, in G---village, injuring villagers' livestock and damaging their rubber plantations. The second incident was perpetrated by Second Lieutenant Tha Beh from BGF Battalion #1014, who on June 17<sup>th</sup> 2015 threatened to kill one or two villagers for allegedly supporting the Karen National Liberation Army (KNLA). The villagers fear the BGF soldiers because they have previously committed numerous abuses toward the villagers in the area and continue to threaten their lives and livelihoods both physically and verbally.<sup>1</sup>

On June 13<sup>th</sup> 2015, at 8:30 pm, a Border Guard Force (BGF)<sup>2</sup> company<sup>3</sup> led by Company Commander Hpuh Lwe Baw, under BGF Battalion #1015, headed by Commander Hpah Nwee, launched mortars and fired small guns into P--- place, in G--- village, Htee Tha Daw Hta village tract, Bu Tho Township, Hpapun District. The shells hit the villagers' buffalos and damaged their rubber plantations. One of the buffalos lost its tail after being hit by shrapnel and has since stopped eating, likely due to the pain from its injury. The villagers were frightened by the shelling and temporarily ran away from the village. The BGF soldiers later told villagers that they fired their weapons because they were being haunted by a ghost.

<sup>&</sup>lt;sup>2</sup> Border Guard Force (BGF) battalions of the Tatmadaw were established in 2010, and they are composed mostly of soldiers from former non-state armed groups, such as older constellations of the DKBA, which have formalised ceasefire agreements with the Burmese/Myanmar government and agreed to transform into battalions within the Tatmadaw. BGF battalions are assigned four digit battalion numbers, whereas regular Tatmadaw infantry battalions are assigned two digit battalion numbers and light infantry battalions are identified by two or three-digit battalion numbers. In addition, on June 17<sup>th</sup> 2015, Second Lieutenant Tha Beh,<sup>4</sup> a BGF platoon commander from BGF Battalion #1014,<sup>5</sup> went to A--- village, Meh Pree village tract, Bu Tho Township, and threatened to kill one or two villagers. His reason for the threat was the alleged exclusive support of Karen National Liberation Army (KNLA) soldiers and lack of support for BGF soldiers by some of the villagers. As a result, the villagers are afraid of him. Second Lieutenant Tha Beh is notorious in the area, as he has previously violently abused villagers<sup>6</sup> and ordered villagers to do forced labour.<sup>7</sup>
