## Toungoo Incident Report: Car accident kills a man in Thandaunggyi Township, July 2017

This Incident Report describes a car accident that occurred at the crossroad between E--- village and Thandaunggyi Town, Thandaunggyi Township, Toungoo District. This incident killed one person and injured eight other people. The victims' families asked for at least 8,700,000 kyats (USD 6,464.6)<sup>1</sup> for compensation from Lance Corporal Aung Min Naing.

# Incident Report | Thandaunggyi Township, Toungoo District (July 2017)

The following Incident Report was written by (1) a community member in Toungoo District who has been trained by KHRG to monitor local human rights conditions. It is presented below translated exactly as originally written, save for minor edits for clarity and security.<sup>2</sup> This report was received in July 2017 along with other information from Toungoo District, including one other incident report, nine interviews, one situation update, 186 photographs and 4 video clips.<sup>3</sup>

## **Part 2 - Information Quality**

#### 1. Explain in detail how you collected this information.

I received a phone call from E--- villagers and I was told to come and document this incident in E--- village.

#### 2. Explain how the source verified this information.

People who witnessed the accident first-hand and the victims themselves disclosed information about the incident to me, so the information is true.

## Part 3 – Complete Description of the Incident

#### Describe the Incident(s) in complete detail.

A car accident occurred on the steep crossroad between E--- village and Thandaunggyi [Town] in Thandaunggyi Township, Toungoo District on July 7<sup>th</sup> 2017.

The car (car plate – YGN7G 2807) was driving fast and was unable to stop when it reached the E--- crossroad. The car hit a 36-year-old man named F--- who stood on the side of the road. He was killed by the impact. In addition, the vehicle crashed into pastor Saw J---'s car, which was parked on the side of the road. This crash also

damaged a residence/shop and a rest house built by E--- villagers.

This car accident instantly killed Saw F--- and injured eight passengers who were sitting in pastor J---'s car. They were about to travel to [Thandaunggyi] town. The injured victims included Naw H--- (36 years old) who sustained a fracture in the lower back, Saw G--- (70 years old) who sustained injuries to her nose and head, Saw K--- whose head was also injured. L---, Naw M---, Naw N--- and pastor Saw J--- were also in the car during the accident.

This car accident happened because the driver, whose name has not been officially confirmed, was careless. He drove away immediately after the accident occurred. Burma/Myanmar Township police officers came to the location where the accident took place and investigated what happened. Two cars and the injured victims were taken to the police station as evidence for this accident. However, the perpetrator has not been arrested yet.

The owner of the car [Lance Corporal Aung Win Naing] and his relatives did not show up to Saw F---'s funeral to take responsibility for the accident or to console [the victim's family]. On July 10<sup>th</sup> 2017, Major Myo Min Than, the car owner Lance Corporal Aung Myo Naing and a group of their soldiers came [to E--- village] wearing military uniforms and equipped with arms. They met with the E--- village administrator to negotiate with the victim's family. The victim's family were asked to drop the case.

However, F---'s family and villagers [including the injured victims] requested to receive at least 8,700,000 kyats [USD 6,464.6]<sup>4</sup> as compensation for the death of the victim, the injured victims and the damage to vehicles and the shop. The car owner Lance Corporal and Major Aung Myo Min did not say exactly whether they will pay [the requested amount] or not, but they arranged to meet with the villagers again on July 20<sup>th</sup> 2017. They donated 100,000 kyats (USD 73.95)<sup>5</sup> to Saw F---'s funeral. However, they did not show up to the funeral on July 20<sup>th</sup> 2017, which upset Saw F---'s family and other villagers. According to the villagers, the members of Tatmadaw do not value or respect them.

This photo was taken on July 28<sup>th</sup> 2017 in E--- village, Thandaunggyi Township, Toungoo District. The photo shows a meeting that was held to offer compensation to the victims of the car accident. The car owner, Lance Corporal Aung Min Naing, along with a Major and a Bu Yin Naung military training officer Major, came to E--- village to meet with the local community. More than 60 villagers attended the meeting. During the meeting, an officer of Bu Yin Naung military training camp, Major Myo Min Than, did not allow the villagers to take any photos. He threatened to take legal action against any villagers who took photos. The villagers could not take any photos as evidence of this negotiation process. Moreover, the villagers did not receive any compensation. This photo was secretly taken by a member of KHRG. [Photo: KHRG]
